1. Subdivision and Site Plan Regulation Review

The PB members were given copies of the updated Subdivision and Site Plan Regulations as prepared by Scott Bourcier, Dubois & King. P. Carideo reminded the group that they have been reviewing the Subdivision Regulations for close to three (3) years at this point and he is anxious to have them adopted at a public hearing this coming March. The Subdivision regulations include the updated lighting regulations, driveway regulations, and roadway specifications.
