#### **New Business**

Household Hazardous Waste- There was a request from Plaistow to hold a meeting on Jan. 21<sup>st</sup> in Plaistow to go over the program and the future rotation. E. Cabral and R. Davis will attend. T. Harrington will get the information on the Chester, Hampstead and Kingston HHW events to show the costs between the three companies.

Friends of the Library-T. Harrington reported that she received a call from one of the members of the Friends of the Library to see if they would be able to get their own trash cart. In talking about the Friends Clothing Closet, they have a lot of clothes that they received that they are not able to sell and not able to donate. This creates an issue for them so they were looking for a trash cart. T. Harrington explained about the textile collection at the Central School. E. Cabral will reach out to the company that has the bin to see if they could do a one time pick up at the library for what they have now (about 50 bags) and if they could be on a regular pick-up rotation at no cost going forward. T. Harrington will hook up E. Cabral with the Friends of the library. R. Davis will also stop in during one of her trips to the library.

*Curbside Pickup/Recycling-* Looking at the 2022 final totals the tonnage is about 100 tons less than the prior year.
