## Minutes from Site Visit at 70 & 90 Depot Road December 10, 2022 at 9AM

A meeting of the Planning Board was held on Saturday, December 10, 2022 at Map 01-091-01 & 091-02 Cameron Court aka 70 & 90 Depot Road at 9AM.

The site walk commenced at 9AM. There were copies of the plan sets available for those who were interested. Those in attendance began to walk the property from what would be the "entrance road" to the project and headed toward the area of the proposed cul-de-sac. D. Soucy asked T. Lavelle if the stone wall that ran parallel to Depot Road was noted on the plan. D. Soucy asked why the road was not staked out and T. Lavelle stated they did not have time between 12/5 meeting and this 12/10 morning.

T. Lavelle stated that the blue stakes represent test pits. There was some discrepancy with the markings on a couple of the test pits. T. Lavelle stated he would go back and review his field notes to resolve the discrepancies.

Some members of the group made their way to the area of clearing located on the back left side of property along the stonewall. D. Soucy noted that although it was 12/10 some areas of the ground were still wet, stepping through puddles.

L. Eaton and D. Soucy measured out and took pictures from the stonewall at 30 feet and 50 feet to show a possible buffer area. M. Hanides took pictures for the file (part of minutes).

The meeting was wrapping up and D. Soucy asked Chairman Weimar to summarize his takeaways from the visit. R. Weimar asked that the well locations of the abutting properties be identified, T. Lavelle agreed. R. Weimar stated he would like to see a formal landscape plan. T. Lavelle stated he would reconfirm location of the test pits and log.









