

## Town of Hampstead - 2021 Transfer Station Regulations

- Transfer station permits are required to access landfill.
- Annual permit must be purchased from the Town Clerk prior to visiting transfer station (\$25.00/year).
- Permit requirements are strictly enforced.
- Permit should be placed in the left-hand side of your windshield.
- One day permit \$25.00 (passenger vehicle, pickup truck, U-hall) AND resident is required to purchase a season permit along with one-day pass

**Residents are required to purchase specific dollar coupons at the Town Clerk’s Office for the following items:**

Mattress/Box Spring, Crib & Twin	\$40 (each piece)
Mattress/Box Spring, Full/Queen/King	\$40 (each piece)
Car & Light Pick-up Truck Tire	\$4 each (remove rims)
Appliances containing Freon	\$20
Television/Monitor, up to 24 inches	\$10
Television/Monitor, over 24 inches	\$20
Console Television	\$30

**Directions to transfer station:**

From the Town Office Building on Main Street, follow Route 121 to Kent Farm Road, turn right on Kent Farm Road. Follow Kent Farm Road, bearing left at the “Y”. The landfill area is approximately 1 mile further on the right.

Commercial operators, including general contractors who contract with Hampstead residents, to remodel and/or demolish buildings or any parts thereof, will be considered to be commercial ventures and **will not** be admitted to the landfill. Option is the Raymond Transfer Station- Route 107 (Prescott Rd,) Raymond (603-778-2116).
